Indonesia as partner country has a theme 'Indonesia, Infinite Journey'. Together with more than 150 fervent Indonesian co-exhibitors, the New Capital City "Nusantara" is presenting its showcase of the latest progress of its development and investment.

But the most important is to invite and convince investors and international media that Nusantara is National Project mandated by law. The relocation of Indonesia's capital city to Nusantara is part of the strategy to realize Indonesia's 2045 vision. Nusantara is modern city; green, smart, inclusive, resilient, and sustainable.

Nusantara Capital City will be a sustainable smart forest city that represents the use of the latest technologies and innovations that enable new models of social, economic and environmentally sustainable growth to create cities that are liveable fairly.

Nusantara is designed and built to have zero emissions, use of clean and renewable energy, environmentally friendly transportation, and smart mobility with around 65% intended for protected forests to restore the glory of tropical forests and 35% will be the urban areas.

Where various main infrastructures are being developed progressively, including the area of the State Palace, sharing offices for ministries and state civil apparatus (ASN) housing. According to the plan, the transfer of state civil apparatus will begin in 2024 and the 79th anniversary of the Republic of Indonesia's independence will be held in the new capital, Nusantara.

According to the Secretary of Nusantara National Capital Authority, Dr. Achmad Jaka Santos Adiwijaya S.H., LLM, the development of Nusantara Capital City is on target. Currently, more than 30 development projects are underway, including presidential and vice-presidential palaces, ministry offices, dams, roads, and workers' quarters.









Indonesia welcomes the high interest of investors in participating in the development of Nusantara Capital City, a forest city that can overcome the climate crisis. Therefore, the government of Indonesia facilitates investment in Nusantara, by issuance of the Government Regulation (No. 12 of 2023) concerning Business Permits, Ease of Doing Business, and Investment Facilities for Business Players in Nusantara. The purpose of this regulation is to provide greater certainty, opportunity, and participation for domestic and foreign investors to accelerate the development of Nusantara.

"We hope that more world class investors will be able to take advantage to invest in Nusantara. The very best facilities will be provided for the convenience of doing business in Indonesia's future capital city, Nusantara," added Jaka Santos.

Several ease of doing business facilities for investors include Tax Holiday, tax reduction of up to 100% for investors in infrastructure, economic generation, and other businesses, including for sector of the Regional Financial Center. Then there is also Super Tax Deduction, import duties and convenience for imports of capital goods, as well as free import duties for imports of materials and goods are explained.

Therefore, in this opportunity, we invite global business owners and investors to take part in this extraordinary and rare opportunity and to be part of the history of the development of a new civilization in Nusantara, the new capital city of Indonesia.
